- 1. Meeting Called to Order at 11:04AM

- 3. Approval of the Minutes from June 22, 2022. Rob to circulate the minutes and approval is deferred until the next meeting.
- 4. Financial Statements:
 - a. Rob requested the reversal of the Year-end accruals to reflect actuals.
 - b. Arrears summary, it was anticipated that with the change of management that there would be significant arrears. Currently about 607 lots are in arrears, down from over 700.

Old Business

- 5. Lighting Repairs:
 - a. The contractor has access to all of the boxes, still some issues, the wiring is complex. And onsite meetings with the contractor are the best option. Astoria to coordinate the onsite visit with the contractor.
 - b. We need to consider the Repair vs. replacement costs in the assessment of this issue.
- 6. Website / Ivernet Services Duplicated
 - a. Discussion about cost vs. no ecommerce component.
 - b. Discussion about termination of the contract, believed to be dec 31, 2022. Astoria to look into the Notice period to cancel the service

7. Signage – Fees Due

- a. Fees are to be paid by September 1, 2022, to avoid penalties on the current year's fees.
- b. Signage is to be posted at all three entrances to the Kings Heights Subdivision.
 - i. Heather to Action this item with the city re: permits
 - ii. Astoria to arrange for the signs and placement with large magnetic signs.
- 8. Landscape & Large Flower Pots:
 - a. Rob Do we want to do some extra work on the city beds, Touchups, Pruning & Weed Control?
 - i. Heather will meet with the city (Jeff) re overgrowth of some shrubs.
 - b. Some discussion on additional landscape maintenance such as the installation of wild flowers and other low maintenance landscape features.
 - i. Item Tabled
- 9. Missing Encumbrances:
 - a. All 39 lots have been billed and paid.
 - b. John McDougal advised that we should act as if all of the lots are under the encumbrance. They all get the benefits of the encumbrances.
 - Heather Harke discussed whether we should charge them or reimburse them. We were advised by Astoria that historically all of these lots have paid the HOA fees in the past.
 - c. Discussion: A letter is to be drafted by Astoria from the HOA to the 39 lots. The letter must be addressed to the Legal Title holders of each lot and should be signed by all Board Members.

- d. Discussion: Most Lot owners don't know that there is an encumbrance missing. We could send a registered letter to each legal lot owner requesting participation and placement of the encumbrance.
- e. Discussion: Settlement from Melcor was discussed. It was decided that Melcor was to be given a deadline to respond to the issue. We need to get in writing if Melcor will or will not do the encumbrances. The Board is of the opinion that at this point in time we do not want to accept the proposed cash settlement.
 - i. To be actioned by Astoria : Prepare letter to Melcor re above matter.
 - ii. Motion: Melcor is to place the required encumbrances on the 39 lots that were missed during the subdivision development. Astoria to prepare a draft letter and submit to the Board for approval and revisions if required.
 - iii. Rob placed the Motion, Second by Heather, All in favor, motion approved.

 - a. Les Brown advised that he had noticed that many of the posts in community fencing have significant damage at the base due to the use of the weed whackers used by the city in the maintenance activities. Astoria to provide quotes for protective cladding.
